**Appointment of a proxy**: A member has a right to appoint a proxy for this meeting. A proxy must also be a member of the corporation. A copy of a signed proxy form should be handed to the contact person before the meeting is declared open. No member can hold more than 3 proxies.

#### PROPOSED SPECIAL RESOLUTIONS

The members of **Eastern Maar Aboriginal Corporation resolve**, as a special resolution, to amend the EMAC Constitution to make changes required by the Native Title Legislation Amendment Act 2021 and Corporations (Aboriginal and Torres Strait Islander) Act 2006 in relation to membership and dispute resolution.

Board of Directors - general discretion to refuse membership even if the person meets the membership criteria current Rule 4.9.

#### 1st PROPOSAL

Amend Rule 4.9 by removing all the words within the rule and inserting: "The Board of Directors may not refuse a membership application if the applicant has applied in writing and complies with the Membership Criteria."

#### 2<sup>nd</sup> PROPOSAL

Amend Rules 4.24 and 4.25 by completely removing the current wording and replace it with:

- 4.24 (a) A person's membership to the Corporation may be cancelled by resolution of the Board of Directors if the member is not an Eastern Maar person.
  - (b) Before cancelling the membership the Directors must give written notice of a proposed resolution to cancel the person's membership.
  - (c) The written notice must be forwarded to the member stating that the Directors intend to cancel the person's membership for the reasons specified in the notice and that the member has 14 days to object to the proposed cancellation.
  - (d) Any objection by the member to the proposed cancellation of membership must be in writing and given to the Corporation within 14 days from when the notice is given.
  - (e) If the member does not object as provided for in Rule 4.24 (d) the Directors must cancel the membership.
- 4.25 (a) If the member does object as provided for in Rule 4.24 (d) the Directors must not cancel the membership.
  - (b) The Corporation may only cancel the membership by special resolution at a general meeting.
  - (c) Written notice (including reasons) of a proposed resolution to cancel a person's membership must be forwarded to the member not less than 14 days before the date of the General Meeting at which the resolution is to be considered.



#### 3<sup>rd</sup> PROPOSAL

Amend the rules by inserting a new Rule 4.25A immediately after 4.25.

- 4.25A (a) A person's membership to the Corporation may be cancelled if a Special Resolution is passed at a General Meeting of the Corporation on the basis that the member is not an Aboriginal person.
  - (b) Written notice of a proposed resolution to cancel a person's membership must be forwarded to the member not less than 14 days before the date of the General Meeting at which the resolution is to be considered.
  - (c) The person whose membership is proposed to be cancelled at a General Meeting, must be given an opportunity to be heard at the meeting.

#### 12th PROPOSAL

Amend rule 25.1 by the insertion of "(a)" after 25.1, and add a new rule 25.1 (b) to be included as follows:

- 25.1 (b) If any dispute between the Corporation and any person (not a member of the Corporation) who is or claims to be a Eastern Maar person arises:
  - (i) as to whether or not the person is a common law holder of native title; or
  - (ii) the Corporation's performance of its functions under the Native Title legislation;

that cannot be amicably settled by the Board of Directors, the matter must be referred to a General Meeting of the Corporation for decision.
